LIABILITY RELEASE, WAIVER, AND HOLD HARMLESS AGREEMENT

- I acknowledge that the event takes place on public streets and agree to follow all applicable laws and instructions from event staff and public safety officials. I certify that my vehicle is properly licensed, registered, and insured as required by law and that I will operate it in a safe and responsible manner.
- I understand that event organizers are not responsible for loss or damage to any vehicle, parts, or personal property brought to or displayed at the event.
